This field position will focus on completing quality assurance on vegetation planners and utility brushing crews. This position will be focused on ensuring specifications of integrated vegetation management plans are being met. Required experience includes Grade 12 and secondary schooling in a related discipline. Preference will be given to applicants with utility experience, UTT/UTW certification, 2 or 4-year diploma/ degree in forestry, horticulture, natural resources, or a related field. ISA Certified Tree Worker, Certified Arborist, or Utility Specialist designation would be an asset. Experience related to herbicide application, mulching, tree falling, and tree trimming (climbing and/or from a bucket) is also considered an asset.

Utility Integrated Pole Maintenance Supervision (Manitoba):

This field position will focus on the supervision of crews inspecting, treating, and physically maintaining power pole structures. Required experience includes Grade 12 with a minimum of two years of experience working in the utility industry. Preference will be given to applicants with; Experience with integrated pole maintenance practices, Journeyman Lineman, Powerline Technician, 2 or 4-year diploma/ degree in forestry, horticulture, natural resources, or related field, Project Management, and/or or credentials in a related discipline.

Utility Vegetation Planner (Alberta):

This field position will focus on assessing vegetation around powerlines and creating vegetation maintenance plans on Distribution or Transmission rights of way. Preference will be given to those with electric utility or line clearance experience; 2 or 4-year diploma/ degree in forestry, horticulture, natural resources, or related field. ISA Certified Tree Worker, Certified Arborist, or Utility Specialist designation would be an asset. Experience related to herbicide application, mulching, tree falling, and tree trimming (climbing and/or from a bucket) is also considered an asset. Strong computer skills with a wide range of applications from Microsoft Excel to GPS technology will be used in this position.
