You will be part of the team accountable for the development of the Forest Management Plan, Annual Work Schedules, and Annual Reports consistent with Ontario's Forest Management planning requirements. The position can be based either out of our office in Nairn Centre or Thessalon, Ontario.

### **RESPONSIBILITIES:**

- Develop the 2020 Forest Management Plan
- Develop Annual Work Schedules and Annual Reports consistent with the approved Forest Management Plan and Forest Management Planning Requirements.
- Ensure all operations are consistent with FSC certification standards for the Northshore Forest.
- Assist Overlapping Licencees and Contractors during the implementation of planned operations.
- Liaise with the Overlapping Licencees, Shareholders, Aboriginal Communities, Ministry of Natural Resources and Forestry, and stakeholders.
