Current Opportunity:

The WGCF Corporation is seeking an experienced, dependable and enthusiastic Forest Professional to fill the position of General Manager. Reporting to the WGCF Corporation Board, the General Manager is responsible for overseeing all aspects of forest management operations including higher levelplanning, development, harvesting, and silviculture. The GM will be overseeing the work of consultants and contractors, and liaising with First Nations, the public and government officials.

The General Manager must have a strong understanding of small tenure operations, and, in particular, the unique opportunities afforded by the Community Forest tenure. This is the forestry you have always dreamed of.

Responsibilities:

- Coordination of Full Phase operations for 2 separate licenses (CFA and FL), including higher level planning through to stand tending
- Develop and implement operational plans that align with the Corporation's Strategic Plan, including Forest Stewardship Plan, Management Plan, Communication Plan, Annual Work Plan
- Coordinate with other consultants/specialists as required to meet the Community Forests Goals and Objectives
